All entries must consist of a completed Sweepstakes entry form submitted to an employee at the Achieva Credit Union 4th Street Branch (413 62nd Ave N, St. Petersburg, FL 33702). Achieva Credit Union will not be responsible for incomplete, lost, or illegible entries.
- 4. Prize and Winner Selection: Winner Selections: One (1) winner ("Winner") will be selected on Thursday, August 26, 2013. The Winner will be selected from the entries received throughout the sweepstakes period. After the winner has been selected, all remaining entries will be discarded. The selection will take place at the Achieva Credit Union 4th Street Branch. You do not have to be present to win.
- 5. Prizes and Odds. One (1) Winner selected on August 26th will receive a Golf Gift Basket. Odds of winning depend on the number of eligible entries received.
- 6. Winner Notification and Acceptance. The Sweepstakes winner will initially be notified on the date their winning entry is selected.
