How does Achieva Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does Achieva Credit Union collect my personal information?	We collect your personal information, for example, when you Open an account Pay your bills Apply for a loan We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on the account.	
Why can't I limit all sharing?	Pederal law gives you the right to limit only sharing for affiliates' everyday business purposes - information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • Our affiliates include Achieva Insurance Agency, LLC.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Achieva Credit Union does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners include providers of financial products and services such as investment and insurance products.
